- Receipt, aggregation and loading area for bulk Green Waste (eg GO bins, Council Parks & Gardens materials)
- Consideration of impacts of RAV network feasibility for outgoing waste trailers upon site space allocation

1 WESTERN METROPOLITAN REGIONAL COUNCIL

The Western Metropolitan Regional Council (WMRC) is classified as a Regional Council in accordance with the Local Government Act (WA) – 1995 and is an organisation formed to provide specialist waste management services for its five (5) Member Councils:

- 1. Town of Claremont
- 2. Town of Cottesloe
- 3. Town of Mosman Park
- 4. Shire of Peppermint Grove and
- 5. City of Subiaco

These include waste transfer, community waste drop off facilities and waste education and promotion.

WMRC operates on a shared services model, providing collective services across Perth's central western suburbs that would be impractical or unaffordable for their individual members to do for themselves. In addition to the Member Councils, WMRC provides some waste management and education services for other councils who, whilst not members of WMRC, achieve community or commercial benefits from utilising the Recycling Centre.

Details of its operations, strategic documents and services can be found from its website - Western Metropolitan Regional Council

2 WEST METRO RECYCLING CENTRE

The Principal operates the West Metro Recycling Centre (Recycling Centre) located in Shenton Park, WA. The Recycling Centre is located on ~ 1.53 Ha of Crown Land under a Management Order in favour of the WMRC.

It currently provides the following operations:

- Receipt, weighing, short-term storage on site, consolidation and transfer to offsite processing for kerbside resident Red Lidded residual waste Bins and Green Lidded FOGO bins
- Receipt, weighing, short term storage on site, consolidation for offsite processing of Green Lidded GO bins and Council collected Green Waste
- Drop off of recyclable materials and household hazardous waste by residents of Member Councils and selected other Councils.
- Fee for Service area for drop off of other materials for disposal by residents and commercial businesses (including Construction & Demolition waste, Green Waste, Landfill Waste, Asbestos, Tyres, Mattresses and Whitegoods)

At the present time, ~ 40% of the Land has been leased by WMRC to an entity (DiCOM) who were developing a standalone waste management and processing facility. This facility is not operational. For the purposes of this Concept Redevelopment Plan it is to be assumed that the DiCOM facilities and infrastructure will be removed from site prior to the implementation of any outcomes from the Redevelopment Plan.

Attachment 1 to this RFQ provides further background information regarding WMRC and the Recycling Centre.

3 REDEVLOPMENT OF THE RECYCLING CENTRE

3.1 Background

In late 2024, Council of WMRC considered the future of the Recycling Centre in context of managing some latent operational issues needing urgent attention.

They adopted a three phase approach to the matter:



Phase One is a discrete project to replace the infrastructure and equipment that is used to load MSW residual (Red Lid Bin) waste from the receiving bunker into silos for trailer shipping to off-site processing. This work is to be completed in 2025. It is viewed that the outcomes of Phase One build works are viewed as solving an immediate need and would not necessarily constrain thinking for an overall redevelopment of the site.

Phase Two 'Site Layout' refers to the subject of this RFQ – development of a Concept Redevelopment Plan. Phase Three will then be the construction and implementation ('development') of the adopted Plan over time in stages.

3.2 Design Briefing Development

WMRC Executive Staff considered how best to develop a design brief for this RFQ. It determined that key questions needed to be answered about the future of the Recycling Centre:

- What should WMRC be doing at the Recycling Centre (i.e. what services should WMRC be providing and what services could be considered in the future)?
- Based on the site footprint, where should WMRC be undertaking those services?
- How should WMRC be undertaking those services to be provided at the optimal cost and environmental outcomes (i.e. what technologies and partnerships could support the delivery of those services at the Recycling Centre)?

In April 2025, WMRC in collaboration with Western Australian Treasury Corporation (WATC) undertook an Investment Logic Mapping workshop with participants from Industry, Staff and Councillors to answer these questions.

After this workshop, WMRC and WATC refined the outcomes of the workshop to develop the brief for this RFQ.

4 SITE INSPECTION AND BRIEFING

The nature of this project and the intricacies involved render it necessary that prospective Consultants are fully aware of the issues prior to submitting a quotation for the services.

A MANDATORY site inspection and briefing at the West Metro Recycling Centre, 61 Lemnos St Shenton Park. Two sessions will be scheduled, at 9 am on Monday 11 August 2025 and 2 pm Wednesday 13 August 2025. Prospective Consultants who fail to attend one of these briefings will not have their RFQ response considered further.

Prospective Consultants shall register their intent to attend this Briefing via email to brett.jackson@wmrc.wa.gov.au no later than 5 pm, Friday 8 August 2025.

5 DESIGN BRIEF

5.1 Primary Functions to be Retained

The Concept Redevelopment Plan shall ensure that the following existing core undertakings are maintained (albeit possibly in different locations in the Recycling Centre than at present):

- Enclosed Bunker area for receipt of waste collected from residential kerbside Food Organic and Garden Organic (FOGO) Green Lidded Bin and Residual Waste Red Lidded Bin by Member Councils. Attachment 5 provides detail of how this waste is currently managed.
- Community Drop Off area for materials to be recovered or recycled which currently are:
 - Mixed Scrap Metals
 - Unwanted clothing for third party clothing bins
 - Bicycles

- Containers for Change donation bins
- Cardboard
- Household Hazardous Waste (see https://www.wmrc.wa.gov.au/recycling-disposal/west-metro-recycling-centre/household-hazardous-waste/) for the variety of materials accepted
- o Cooking oil
- o Corks
- E-Waste (see <u>Electronic Waste | Western Metropolitan Regional Council</u>) for variety of materials received
- Glass Bottles & Jars
- Motor Oil
- Paper (un-shredded)
- Polystyrene
- Some sporting goods
- X-Rays (deposited in secure shredding bins)
- 'Fee for Disposal' Commercial Drop Off area for materials, which currently are:
 - Asbestos
 - Construction and Demolition Waste
 - Bulk Waste
 - Green Waste
 - Mattresses
 - Whitegoods (Refrigerators, Freezers, Dryers, Ovens, Air Conditioners and the like)
- Gate House to receive incoming vehicles, direct customers to the appropriate drop off areas and take payments via POS device
- Weighbridge adjacent to Gate House for weighing and recording selected incoming and outgoing waste loads on trucks.

5.2 Capacity & Throughput

General

Essentially the Recycling Centre is a Transfer Station whereby unaggregated waste is received, aggregated for loading and transported to offsite processing facilities.

The Recycling Centre achieves efficiency and affordability by optimising:

- space allocation for storage / stockpiling of various waste streams,
- plant & infrastructure for loading and
- transport costs based on number of trips made to processing facilities.

The Recycling Centre has a DWER Site Licence which outlines capacity limits and conditions of operation that WMRC must follow. Attachment 6 provides a copy of the current site licence from DWER. (Application is underway to seek amendments to Site Licence for increased

volume of Household Hazardous Waste & E-Waste and extended storage times of putrescible waste on site from 24 hours to 72 hours. Indications are that this application will be successful).

The Concept plan is to identify the preferred layout of functional areas and process technologies for a 30-year design horizon with the flexibility to stage the development of functions or capacity over time.

Waste Bunker

The Bunker is to be planned for increased capacity for higher volumes of incoming waste to cater for both natural increase as population growth occurs and WMRC attracting new Council customers. Presently the Bunker manages:

The Bunker shall be able to cater for a future capacity after 30 years of **5 times** the current incoming volume. This capacity forecast is based on growth in residence numbers in Member Councils, but also the planned capacity to attract new Councils for receipt of kerbside Mobile Garbage Bin (MGB) residual & FOGO waste, FOGO sourced from food and beverage businesses and possible new kerbside waste streams to be collected and disposed of.

The Concept plan should consider that the ultimate bunker building footprint is identified and possibly developed in one stage, however receipt and loading infrastructure such as compactors, walking floors, loading facilities and the like could be staged over time.

Presently, works are underway such that residual and FOGO waste is loaded into a chute that feeds into a Wastech S4000 horizontal compactor for loading into rear loading & discharge blade ejection trailers at a lower level for haulage off site. The Design shall consider the feasibility of this arrangement for long term needs.

The Concept plan needs to identify the preferred system of waste aggregation in the bunker and methodology for loading onto waste trailers for haulage to offsite processing facilities.

'Fee for Disposal' Commercial Area

The table below shows the CURRENT relationship between areas allocated for various waste streams and the resultant frequency of outgoing truck movements to keep the stockpiles of these waste streams within manageable volumes.

The Concept plan shall consider incoming volumes after 30 years of **3 times** of the current volume of each waste stream, with a design prioritising increased storage areas over that of higher rate of outgoing transport trips within existing stockpile footprints.

Community Drop Off Area

The community drop off area presently is \sim 1,200 m² in area (including waste storage areas and customer vehicle parking & circulation).

Growth in this operation is envisaged to be

- · acceptance of new types of 'household' waste streams,
- facilities for drop off of separate metal streams (clean ferrous, copper, stainless steel etc)
- Increased number of drop offs stemming from the service being provided to additional Council residents

The Concept plan shall consider an appropriate layout and footprint suitable for the next 30 years commensurate with above growth expectations.

The Concept Plan shall consider and incorporate ways in which there can be physical separation between the public dropping off materials and WMRC staff using plant to load the materials for offsite processing.

It shall also consider and incorporate space whereby materials that have been dropped off but have potential for sale in a tip shop can be sorted and stored.

It will need to incorporate covered areas for various waste streams that are necessary under the DWER Cat 62 Licence.

It will need to consider bespoke waste storage infrastructure such as used motor oil bunker, household hazardous waste, batteries, cardboard compactors and CDS containers.

5.3 Weight of Waste Streams

The variety of materials received along with the mix of customers (residential, commercial and council) and practicality of weighing small volume individual waste streams results in a process of

- actual weights of some higher volume / single product waste streams (predominantly commercial operators) using the weighbridge and
- estimated weights of low volume / mixed waste streams (typically community drop off or smaller commercial operators)

This impacts how the gate house & weighbridge are currently laid out and the vehicle movement paths. It does also result in some level of 'discussion' between Gate House staff and customers when Gate House staff estimate weights of incoming waste for purposes of charging customers.

An objective of the Concept Plan would be to develop new infrastructure and facilities that would increase the proportion of incoming residential and commercial waste streams that are physically weighed rather than estimated.

The following different processes occur which need to be improved for efficiency and effectiveness in the new Concept Plan:

Incoming 'Fee for Disposal' Commercial Waste

Smaller loads have their waste estimated by the WMRC gate house officer and charges applied. Larger loads require the customer to have their incoming vehicle weighed over the weighbridge, directed to the drop off area and return to the weighbridge (using external road network) for measurement of empty vehicle weight, thus calculating weight of waste delivered.

An objective would be to deploy improved technologies to provide more accurate measurement of incoming waste weights to provide more accurate cost structures to customers.

Incoming Community Drop Off Waste

Gate house staff examine the resident's vehicle (and any trailer) for the types of materials and record the entry of the resident against their relevant Council. Checks are made that materials to be dropped off do not exceed proscribed limits.

The consolidated outgoing waste is weighed by relevant waste stream.

Incoming Council Kerbside Bin Waste

Most Council owned or Council contracted waste vehicles have their registration and vehicle mass data (gross, tare, etc) preloaded into the WMRC system. As they enter site, their gross mass is recorded over the weighbridge. The vehicle is directed to the waste bunker for tipping. The waste load is calculated as thus calculated.

If a waste truck arrives that is not registered in the WMRC system, the vehicle then must exit the site via the Lemnos St exits and re-enter via the Brockway Rd entry to have the empty weight recorded for calculation of waste provided.

An Improved flow and layout are necessary such that circular, intersecting and counterflow movements are avoided.

Outgoing Waste (loaded onto hook lift bins or moving floor trucks)

These services are provided by WMRC Contractors.

They enter the site from Brockway Rd and proceed to the relevant waste area to load the hook lift bin or waste truck the exit the site onto Lemnos St and proceed to the relevant waste processing facility.

They return to the site with an empty bin (for drop off at the waste receipt area) and the weight docket from the processing facility which is entered into the WMRC system.

In some circumstances, a fully laden Truck will be recorded over the weighbridge prior to departure from the Recycling Centre with waste load calculated from that operation.

Outgoing Waste (Waste Bunker)

Once a waste truck and trailer are loaded with waste from the Bunker, it leaves the site and returns to the weighbridge for recording of gross weight from which outgoing waste is calculated. This is necessary partly to ensure that the Gross Carrying Mass of the laden truck and trailer does not exceed permitted weight on the road network.

Some newer waste trailers have on board load sensors which (with the GVM of the truck and trailer) will provide drivers with the calculation of Gross Carrying Mass negating the need to pass over the weighbridge on exit.

They return to the site with an empty trailer (for drop off at the bunker loading area) and the weight docket from the processing facility which is entered into the WMRC system.

As implied above, the current processes have inefficiencies due to the constraints of the site and layout of various infrastructures.

5.4 Functionality Outcomes

Separation of Vehicle Streams

The Concept plan needs to examine the current vehicle streams and flows and make improvements that are safer, more intuitive, more efficient and thus provide an enhanced customer experience.

The following matters are important:

- Community drop area vehicle movements are predominantly light vehicles
 with/without trailers by customers who are not familiar with the site. They
 predominantly visit only the community drop off area and then leave site however a
 small proportion would need to continue to the fee for disposal drop off areas for
 other waste streams. Key risks in this area include drivers not being aware of mobile
 plant in operation as well as not driving correctly within site.
- Fee for disposal drop off areas are a mix of light vehicles and commercial vehicles being residential, commercial and some customer council vehicles. Some come with small trailers whilst others have substantial trailers. Some are familiar with site and others aren't. They usually only need to reach this area (after paying fee as appropriate), unload and then leave site. Some need to be weighed for waste disposed. Key risks in this area are managing congestion when multiple users are on site as well as the need for mobile plant to load into waste containers from stockpiles whilst the public are on site.
- Council kerbside rubbish trucks have no other need than to enter the waste bunker, drop off their waste and have the waste weighed. Drivers are familiar with the site.
 Key risks are limited to the interaction between rubbish trucks during their tipping operation and WMRC plant and staff
- Outgoing WMRC kerbside waste disposal trucks and trailers have no other need than being able to enter site, access the bunker loading site, load, have weight verified and leave site. Key risks are predominantly their interaction with incoming customers vehicles.

Protection of People from Mobile Plant

Community and Commercial Customers will leave their vehicle for unloading of their waste. WMRC mobile plant will also move around the site collecting and loading waste into the relevant bin or storage area. As much as practical and cost effective, the highest order acceptable solutions would be to engineer out through good design, points of conflict where people may be in the path of travel of mobile plant. The lowest order acceptable outcome would be operational procedures that exclude people from areas during mobile plant movements and operations.

Reduced 'circular' movements

The Concept plans need to develop layouts and infrastructure such that the number of vehicle movements that are required to exit and re-enter site in order to validate the weight of waste received (or being exported).

Off Street Queueing

The Concept plan, in consideration of incoming community, commercial and council truck movements shall provide sufficient off street queueing capacity for the 30 year design horizon such that queueing onto the road only occurs in extreme peak times.

Improved Waste Bunker Infrastructure

To meet likely DWER Licence Conditions of Category 62 Waste (Solid Waste Depot), it is almost certain that some Putrescible Waste (i.e. FOGO and Residual) will need to be delivered to an enclosed facility from which it can be held prior to loading onto waste trailers.

The Concept design shall identify the optimal building layout and location and internal waste movement systems that meet regulatory needs, efficiency of operation and constructability within an operating facility.

A 'flow through' rather than single entry / exit into the bunker is mandatory.

Layout and technologies for loading waste into 60m³ tri-axle and 63 m³ quad axle capacity rear loading/ unloading blade ejection trailers are necessary.

Improved Waste Transfer Efficiency

A technical assessment has been undertaken in regard to the existing Road Network between the Recycling Centre and Residual kerbside waste & FOGO kerbside waste processing facilities. It demonstrates that the existing road network is at least RAV 2 compliant for the entire journey. As such, WMRC could utilise B Double truck and trailer combinations for haulage of a combined payload of 40 Tonne of waste which would result in more efficient waste disposal and cost savings.

Accordingly, the Concept Plan shall provide sufficient space such that trailers can be loaded, stabled and made up to B Double consists for haulage.

Improved Outdoor Waste Storage areas (both Community Drop Off and Fee for Disposal areas)

The objectives of the new design for these areas are as follows:

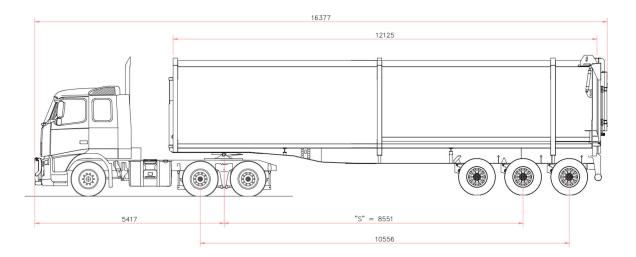
- To provide customers with a simple to understand and intuitive wayfinding and parking experience to each waste stream for drop off
- To develop waste loading infrastructure that separates plant from people as much as possible
- To have adequate storage areas for each stream
- To be able to grow and accommodate new waste streams that may be required in future (eg discarded solar PV panels)
- To have good level of storage infrastructure including cover, drainage, levels etc to meet likely Licence conditions
- To have adequate first response fire fighting infrastructure for staff to attend to spot fires from combustible sources (eg tyres, batteries)
- To consider improvements to storage and loading of each specific waste stream in terms of continued use of existing hook lift bin sizes, implementation of larger capacity hook lift bins or use of tipper trucks for haulage in order to reduce operating costs through reduced number of trips (albeit at impacts to storage space requirements)
- Examine layouts that ideally reduce the height of barriers that the public have to lift their disposed waste over whilst still providing edge protection.

Plant and Vehicle Storage, Fuel Bowser & Tool Store

A suitable area of $\sim 120 \text{ m}^2$ shall be provided where mobile plant and vehicles can be parked adjacent to a 25 m² area tool store for maintenance and Fuel Bowsers for refuelling.

Trailer Stable

Commensurate with the option of using B Double combinations to haul from the waste bunker, a suitable space shall be provided where ultimately 8 trailers (4 initially) can be stabled. The nominal length of the truck & single trailer combination is shown below:



The Stable shall be located such that both laden and empty trailers can be stored, moved to the waste bunker for loading and area for coupling the B Double combinations for haulage off site.

Staff Amenities

Space shall be allocated for staff amenity building (meal/meeting room for 15 staff, showers, toilets, kitchen); office space for administration (25 m²) and 20m² materials store. On site staff parking for 15 vehicles and 2 visitors shall be provided.

Community Education

The Concept Plan shall consider integration of wayfinding, education signage and viewing areas such that WMRC can conduct site tours for community education purposes outlining the various functions undertaken at the Recycling Centre.

5.5 Additional Service Offerings to be Incorporated in Concept

Expansion of Product Stewardship Schemes

Presently some of the waste streams accepted at the community drop off area are part of product stewardship schemes, whereby (ultimately) the manufacturer of the product is accountable for the proper recovery and disposal of these products at end of life.

The impact on WMRC is usually allocation of space for this waste stream, with third parties being responsible for the infrastructure for drop off and collection of this waste.

The Concept Redevelopment Plan shall provide the flexibility within the Community Drop Off area for future new schemes in terms of space allocation of a notional 50 m² of space.

5.6 Further Service Offerings for Early Evaluation

The following service offerings are seen as lower priority for the Redevelopment of the Recycling Centre. The Design team will evaluate the required land allocation and movement logistics for these offerings as an early piece of work. A subsequent direction will be provided by WMRC whether to continue exploration of these options into final Concept Development Plan.

Enhanced Green Waste Storage

At present Green Waste acceptance at the Recycling Centre comes from the following sources:

- Commercial services providers (eg Residential Tree Trimming services)
- Residential fee for disposal
- Limited acceptance of some Council generated green waste.

WMRC previously undertook Green Waste Acceptance and GO Bin Green Waste acceptance for Member Councils at a separate site. This existing area is notionally 5,000 m² including Green Waste storage, truck loading ramp (for a loader to carry the green waste to sufficient height to tip into the back of a tipper truck and water storage for suppression of dust and fire.

At present, this site is not available, and all Green Waste is managed at the Recycling Centre in smaller stockpiles. This is not a viable long-term solution within the current site layout.

The Concept plan should consider an option of this undertaking being permanently incorporated in the Recycling Centre facility on a smaller than 5,000 m² footprint utilising more efficient storage and loading facilities (on the basis of the DiCOM facilities being removed).

Truck Wash Facility

Identify in the Concept Plan a suitable site where side lift and front lift waste collection trucks from Customer Councils can access the site to have their waste compartments washed out between change in collection runs (ie changing from residual bin collection to FOGO or Recycling etc) in order to minimise contamination.

The facility should be able to manage 2 trucks concurrently with holding bays for a further 2 trucks.

Part 1 READ AND KEEP THIS PART

This facility could have separate entry and exit arrangements with automated billing systems.

Necessary leachate management, water and stormwater facilities shall be indicated on the Concept Plan

The brief is to investigate potential technologies and systems that are in use for this purpose along with likely infrastructure costs to implement. The WMRC will separately determine the Business Case for development of the facility.

5.7 Site Related Matters

Land Assumptions to be made

The Concept Plan is to assume that the existing DiCOM waste processing facility will be deconstructed and removed from site with no major adjustments to site levels. The underlying land is available for Recycling Centre design development. All existing leases and easements on Title in favour of DiCOM would be extinguished.

An existing private Sewer easement and Water Corporation Water & Sewer extends within the site. Development options shall take this into consideration. This easements are illustrated in yellow below:



Site Levels

The Concept design shall consider the benefits of the existing different site levels in terms of aiding materials loading when considering allocation of functional spaces.

The Concept design shall also have consideration of potential future site upgrades in any proposed staging of works.

Road Entry and Egress

Existing entry and exit gates can be considered for relocation if this demonstrates improved internal vehicle flow and appears to have no detrimental impact on traffic flows on relevant roads (Brockway Rd and Lemnos St).

6 SCOPE OF SERVICES

6.1 Project Governance

The WMRC will create a Project Steering Group comprising the CEO, Manager Operations and Project Manager to provide support and guidance for the Consultant. Formal decisions or instructions for the Consultant will come from this Project Steering Group (PSG).

The Consultant shall allow for attendance to meetings & workshops as detailed below as well as a routine fortnightly Teams (or similar) meeting (nominally 1hr duration) with the WMRC Project Manager and production of all necessary meeting & workshop preparatory collateral, minutes and records.

6.2 Underlying Need

The Consultant shall be required to undertake necessary investigations, analysis and design works to develop a Conceptual Redevelopment Plan for the Recycling Centre. This Plan is then to be presented to Council for formal adoption.

First and foremost, it is anticipated that the Recycling Centre will operate predominantly as a Cat 62 solid waste transfer facility with little likelihood of entering on site waste processing activities.

The Concept Plans and accompanying Report should be of sufficient detail that if any development stage proceeds in the short to medium term, that the design team undertaking that work can quickly develop 15% level design drawings and specifications based on this work.

6.3 Consideration of Site Issues

Apart from the Site issues detailed in section 5.7 above, the Consultant shall take the following matters into account during their design:

6.3.1 Utility Connections & Headworks

The consultant is not required to consider the existing capacity of electrical network, water supply and drainage systems nor the need to examine enhancement of these utilities to meet the Redevelopment Plan. These will be undertaken if necessary as subsequent works projects are approved.

However, this does not exclude the requirement to identify a master stormwater layout and leachate management infrastructure prior to discharge to sewer.

Identification of areas for roof mounted solar photo voltaic panels for onsite energy generation would be required.

6.3.2 DWER Environmental Assessment

The Consultant can assume that their role is not to assess or survey existing flora (and fauna) to gauge likelihood and extent of any clearing permit needs. If necessary, these will be attended to as subsequent works projects are approved.

The Consultant shall identify within the Concept Redevelopment Plan:

- Area(s) for new vegetation planting to offset potential cleared areas
- Robust visual screening planting buffers on property boundaries to Lemnos St and Brockway Rd

6.3.3 DWER Waste Licence and Works Approvals

The Consultant can assume that their role is not to assess impacts of the Concept Redevelopment Plan upon the necessity to amend the existing Cat 62 Licence approval and seek Works Approvals. If necessary, these will be attended to as subsequent works projects are approved.

It is almost certain that any DWER approval of a new or amended Category 62 Waste Licence for the site will necessitate attention to:

- Odor management from waste sources
- Leachate management from putrescible waste stockpiles
- Site stormwater management
- Covered, and in some cases fully enclosed waste drop off areas

The Consultant must take these matters into consideration for planning purposes.

6.3.4 Site Topography

To further clarify the intent set out in section 5.7, the WMRC expects that Concept Designs use the existing site topography as a positive feature in developing designs for waste handling and transfer operations.

Of importance would be necessary internal stormwater management system and buried services that allow for cost efficient connection to main discharge points.

It would envisage that wholesale import of fill to achieve new site levels in response to a Concept Design would only be undertaken where they are economically sensible and more practical to achieve better long-term operational layouts.

6.3.5 Existing Waste Bunker

The existing Waste Bunker, along with associated waste chutes and horizontal compactor have a reasonably high financial value within the WMRC Asset Register.

Proposed Concept Redevelopment Plans that consider a complete relocation of the Bunker functionality elsewhere on site can be explored, mindful that the eventual Business Case for such a project would need to include the substantial write down of the existing Assets.

6.3.6 Staging of Construction Works

The outcomes from the Concept Redevelopment plan would detail a staged approach to site improvements. Whilst detailed construction management plans considering existing site operations are NOT a required outcome of the Concept Redevelopment Plan, the Consultant shall take into consideration that existing site operations (albeit perhaps in reduced capacity) shall be maintained during the construction of subsequent stages of development.

This will be a topic of discussion at regular project meetings.

6.4 Stages of the Design Services

The WMRC expects that Consultants will follow the following stages of work to complete the engagement. Prospective Consultants will be able to set out their preferred methodology and tasks within the Quotation offer for consideration by WMRC as long as the underlying needs from WMRC are met.

6.4.1 Project Commencement

- Undertake Site Inspection and familiarisation with Consultant and WMRC Project Manager.
- Site inspection with WMRC Project Manager to confirm DiCOM assets that are most likely to be removed and probable site remediation outcomes.
- Undertake site induction for key Consulting staff to allow unescorted visits as necessary.
- Project Inception Workshop (Consultant and Project Steering Group) to confirm shared understanding of Design Brief and scope of Consultant's services

An existing feature survey of the site will be made available to the Consultant. However, it is unlikely that the DiCOM facilities will be largely removed from site during the extent of the Concept Design project and as such a Post DiCOM site feature survey would not be possible.

6.4.2 Preliminary Concept Plan

Consultant to prepare a high-level space allocation & layout **Preliminary Concept Plan** for discussion with Project Steering Group. This early evaluation will include space for base functionality outcomes, additional service offerings and further service offerings.

It is not anticipated that that this stage will necessitate any financial analysis of each function nor analysis of specialised waste processing, loading or sortation systems unless these systems are fundamental to the determined space allocation.

The Consultant and PSG will then discuss this **Preliminary Concept Plan** to consider which additional and further service offerings will be retained for continued development of the Concept Redevelopment Plan.

The aim is to agree what is reasonably practical to achieve in terms of site facilities without compromising core functionality.

This **Preliminary Concept Plan** will then be updated. The Consultant will then workshop this Plan with the WMRC Council & Administration and such that they have an opportunity to feed into the design process at this early stage.

Consultants are to allow for this workshop to be conducted on an early evening weekday basis (5:30 or 6 pm start, notional 2-hour duration) at premises provided by WMRC.

6.4.3 Initial Draft Concept Redevelopment Plan

The Consultant will then prepare an **Initial Draft Concept Redevelopment Plan**. It is envisaged that this plan will have more refined space allocation and layouts than the earlier Conceptual Early Evaluation Plan along with a high order capital cost plan.

It will include the selected service offerings. It will include evidence of investigations or analysis undertaken to support the proposed layouts and services.

It will include both diagrammatic and discussion paper analysis of:

- Layout and space allocation for each function or facility
- Vehicle movement paths (customers, plant, incoming and outgoing waste trucks)
- Waste management technologies proposed.

It shall also consider some options for each layout, vehicle movement paths and technologies.

The Consultant will then workshop this Plan with the PSG and take on board feedback and directions to refine the options into a preferred concept.

6.4.4 DWER Consultation

The Waste Industries (Environmental Regulation) area of DWER would need to be consulted with once the Preferred Draft Concept Plan has been finalised. They will not be required to endorse or approve the Plan, however any feedback that they provide should be considered further.

The Consultant shall allow for a 2 hour maximum meeting with DWER during normal Business Hours to be conducted at either WMRC office or DWER office.

6.4.5 Member Council Consultation

The Consultant and WMRC PSG members will then present the Plan in its current form to Administration staff of the Member Councils (CEOs and Waste Managers) for discussion.

Feedback will be taken on board by the PSG, and any changes to the Plan given as a direction to the Consultant by the PSG.

This presentation would be conducted as a group session on a normal Business Day at one of the Member Council offices.

6.4.6 Draft Concept Redevelopment Plan

The Consultant will further refine the Plan with more detailed analysis of capital costs, waste technologies and site layouts.

The Consultant will identify possible staging of implementation of the Redevelopment Plan in consultation with the PSG.

This Plan will then be workshopped with WMRC Council & Administration with the Consultant such that they have an appreciation of the proposed redevelopment prior to the final Plan for adoption at a Council meeting.

This workshop will be conducted in early evening on a weekday to be determined.

6.4.7 Adopted Concept Redevelopment Plan

Once these prior activities have been completed and any further investigations undertaken, the Consultant will finalise the Concept Redevelopment Plan and present to the PSG.

This Plan will then be presented to the Council for adoption at a Council meeting. The Consultant is to allow for attending the Council meeting (early evening on weekdays) to respond to any matters raised in discussion.

7 PROJECT COLLATERAL

7.1 Intent

The WMRC considers that (as a minimum) the Consultant will produce a growing set of drawings and reports as the project progresses through each stage of development.

This portfolio of information will ultimately result in the following project collateral by the end of the Adopted Concept Redevelopment Plan stage:

7.2 Drawings

- Overall site layout plan that is legible when printed at A3
- 'Call out' site layout plans of discrete development stages scaled to 1:200 at A3
- 'Call out' site elevations of discrete development stages scaled to 1:50 at A3
- 'Call out' site sections (especially the waste bunker and loading) scaled to 1:50 at A3

Drawings are to be provided in both .pdf and .dwg format (with all base files that underpin the .dwg drawings).

As detailed in Section 6.4.3, separate plans are required for each of functional layout areas, vehicle and pedestrian movements, main infrastructure layouts and technology layouts. These can be imbedded as layers within .dwg files but must be provided as separate .pdf files. Vehicle movements to include turn path overlays where relevant (notably loading and despatch of waste trailers).

7.3 Cost Plans

Cost plans for construction of the full Redevelopment and individual core components that would be staged. This cost plan can be constrained to:

- Construction cost estimates in 2025 dollars
- Design maturity up to 15%
- Assumed degree of accuracy -20% to +30% is indicated by American Association of Cost Engineering (AACE) Class 4 in accordance with AACE Recommended Practice AACE 56R-08 at end of Adopted Concept Redevelopment Plan phase by Consultant
- Exclusion of design & project management fees, headworks and other statutory charges
- Exclude demolition of any site infrastructure (including DiCOM facilities)
- Inclusion of any build up or reduction in existing site levels
- No allowance for contingency (managed in degree of accuracy)
- Evidence of source of costings (QS, Consultant experience, vendor input etc)

7.4 Report

Consultant is to produce a comprehensive Design Report detailing the works undertaken, options explored and discarded, safety in design considerations, conclusions and recommendations to accompany the Concept Redevelopment Plan. Coloured photographs or images of key technical systems proposed to be used would be included in this report.

The Report shall be provided in Draft format for a single review by WMRC then subject to comments, provided as Final.

8 PROJECT TIMEFRAME

The Principal's preference is that this engagement will be completed within six months from engagement. Prospective Consultants shall refer to the Qualitative Assessment Criteria in this regard.
